



**SYNLAB AG: Disclosure pursuant to Art. 5 Sec. 1 lit. b) and Sec. 3 of Regulation (EU) No. 596/2014 (MAR) in connection with Art. 2 Sec. 1, Sec. 2 and Sec. 3 of Commission Delegated Regulation (EU) No. 2016/1052 – 2 Interim Announcement**

SYNLAB AG announced the beginning of the first tranche of a share buyback program (**Share Buyback Programme 2022-2027/1**) via disclosure under Art. 2 Sec. 1 of the Commission Delegated Regulation (EU) No. 2016/1052 on 24 March 2022.

The total number of shares bought back daily and the daily volume-weighted average stock market prices for the period from May 16<sup>th</sup> 2022 up to and including May 22<sup>nd</sup> 2022 are as follows:
